Senior's Homeowner Rebate Policy

1.0 Policy Intent

The City of Cold Lake wishes to implement a program to provide financial assistance in the form of a rebate to low income seniors who own their home in the City of Cold Lake.

2.0 Purpose

This policy is designed to provide support for City of Cold Lake homeowners who are low income seniors that qualify for the Alberta Seniors Benefit. Low income seniors are generally unable to augment their income to correspond with increases in taxes and may have financial hardship associated with paying their taxes.

3.0 Policy Statement

The City of Cold Lake believes in fair and equitable application of the Senior's Rebate Program (the "Rebate Program"). Low income Seniors receiving the Alberta Seniors Benefit will be obtained from the Province of Alberta to confirm eligibility in the beginning of May. Eligible applicants will qualify for an annual rebate of \$100 and will have it applied directly to their property taxes.

4.0 Managerial Guidelines

Eligibility Criteria

- 4.1 In order for an individual to be deemed eligible to receive a rebate, the individual must meet the following criteria:
 - 4.1.1 be a resident of the City of Cold Lake;
 - 4.1.2 included in the listing received from the Province of Alberta of seniors receiving the Alberta Seniors Benefit.
 - 4.1.3 own and reside at a residential property within the jurisdiction of the City of Cold Lake, which is the principle residence of the applicant.

Rebate Program

4.2 Seniors who qualify will be issued \$100 rebate. The rebate will be applied directly to their property tax balance for the year.
