## *Message from the Mayor*

With an extremely challenging period behind us, residents are joining Canadians across the country in hopes of good news and better times ahead – and things look promising for Cold Lake.

Our recreational facilities have been full, and not only with our hometown teams and kids as they challenge themselves and make friends through sport, but also with teams from out of town. Our local sports organizations have been busy applying for – and winning – bids to host tournaments. could see a significant increase in the number of personnel living here so that the new plane can be flown, maintained, and kept secure.

We've been working to prepare for this growth by balancing investment in crucial new infrastructure with fixes to aging infrastructure, and recreational opportunities that will attract new families and visitors. We are ensuring the city's stormwater and sewer systems are up to date so that our ability to grow is not limited, while also providing what help we can for people who have fallen on hard times.

At the same time, we know that health care has always been a challenge in our region and that the hard times we have experienced also resulted in an increase in crime. These trends are not unique to Cold Lake, but our council has taken steps to address these issues and, while there is work still to be done, we have made significant progress.

From our City's growth, to our continued prosperity, to the challenges we will take on as a community, this annual report is meant to give you a view of where we left off in 2022, and where the future might bring us. # Message from the City Manager

This annual report, of course, is a great chance to revisit what we accomplished as a community in 2022. In our busy lives, it's important to take the time to pause, look back, and take a look around us before we chart our course ahead. All too often, our days are dictated by busy schedules, and we lose sight of where we've come from. This makes it hard to appreciate the progress that we've made – either as individuals, as organizations, or as communities.

This year, we are presenting our financials and our major projects from 2022, but we are also taking the time to look even further back, comparing pictures of what our area looked like long before three communities – the Town of Cold Lake, the Town of Grand Centre and Medley – were amalgamated into the municipality we now call home.

It's amazing to see the transformation that the community has seen over the years. But as much as things may have changed, the basics generally remain the same. We are positioning our community for long-term sustainability by undertaking the construction of a new wastewater treatment plant, building our Public Works Department a new operations centre, and building recreational facilities that will provide generations with the opportunities to compete and excel.

And the work that we are doing – and that those before us have done – is paying dividends. Cold Lake continues to grow at a respectable rate. The City's 2022 census showed that we grew by

four per cent as compared to the Federal Government's 2021 census, reaching a population of 16,302. Unfortunately, it also showed that about 40 per cent of our residents do not have access to a family doctor. That's why council gave us the go-ahead to create a municipally controlled corporation. The corporation – the first of its kind in Canada – has purchased a medical clinic and will now have a seat at the table with Alberta Health Services when it comes to doctor recruitment. Access to a family doctor has been a concern, but we will continue to work diligently on a solution for our community, even if that means blazing our own trail.

As we move forward, we will continue to provide for our residents while tackling challenges as we must. There is little that we, working as a community, cannot overcome. We will also remember to look back to learn lessons, gauge our progress, and find inspiration. But most of all, we will remain focused on the future of our municipality: The services we provide for one another, the community we want to build together, and the opportunities we will leave for our children.

## Strategic Priorities

**PILT**

### Payment in Lieu of Taxes

The City's legal dispute with the federal government over PILT continues. The matter is expected to go to a tribunal in late 2023 or early 2024 for a decision. The City's position is that the federal government shorts PILT payments by about \$1.4 million each year.

**V**

### Vulnerable Population

The City of Cold Lake was able to stand up a shelter for use by the Cold Lake John Howard Society in October of 2022. Council passed a budget of \$625,000 to move, service, and convert a drilling camp onto City-owned land.

**CS**

### Community Safety

Council added an additional RCMP officer in the 2022 budget, passed a bylaw that prohibited loitering in commercial lanes at night, and took measures to end camping and vagrancy on public and private property.

**MC**

### Medical Clinic

The City of Cold Lake stood up a municipally controlled corporation and purchased a medical clinic. CL Medical is run by a board of two councillors and three members of the public at large. See page 7 for more.

### Aquatic Facility

The future aquatic facility for the City of Cold Lake completed its public engagement in 2022, with the architectural firm bringing a conceptual design for the facility to council. The 2022 budget also included an operating reserve to ensure that the cost of operating the facility does not result in a significant one-year jump in the tax rate when the facility comes on-line.

# MUNICIPAL CENSUS

During its 2021 budget deliberations, Cold Lake City Council allocated \$45,000 to conduct a municipal census. Because the number of physicians and access to health care has been a priority, council also wanted to gather information about residents' experiences in accessing family doctors.

This was the first municipal census conducted since 2014. It took place from May 2 to June 22, 2022. The data that a census provides allows for the municipality to gain a clear picture not only of how many residents there are, but also provides a more accurate representation of the current residents in the City.

The census took place in two phases. Phase one was self enumeration, allowing households to complete the census online. Door-to-door enumeration then took place from May 16 to June 22. Overall, 48 per cent of households took advantage of the opportunity to self-enumerate, while 38 per cent of dwellings were enumerated in the door-to-door campaign. The data from the 86 per cent of dwellings enumerated was then used to forecast the population from the 14 per cent of dwellings that were not enumerated.



# CL MEDICAL CLINIC

In response to the data collected in the 2022 municipal census regarding access to family physicians, Council decided to take action in a way that would give the community meaningful access and input to the physician recruitment process.

It was determined that ownership of a medical clinic would allow family physicians to be supported while bringing the community closer to the physician recruitment and retention process. Council decided to take the approach of forming a municipally controlled corporation. This corporation, CL Medical, was established in early 2023, and functions at arms length from the City of Cold Lake. It is governed by a board of two Councillors and three members at large, appointed by Council.


A municipally controlled corporation can function as any other private business. It can purchase assets, hire employees, make a profit and choose to either invest any profits back into the business or distribute them to shareholders. In this case, the City of Cold Lake is the sole shareholder in the corporation.






## **COLD LAKE** THROWBACK

Average Residential Tax Increase or Decrease (%)




The total amount of property tax paid can vary depending on the municipal tax rate, developments in the community, the province’s education property tax, and the seniors property tax. Property taxes are based on market value, including land and improvements. This graph shows the average residential tax increase or decrease over the years, inclusive of municipal property tax, the provincial education property tax, and the provincial seniors property tax. The Government of Alberta sets the amount collected from each municipality to fund education and seniors lodges.




● **Education Tax**  
(Alberta School Foundation Fund and Lakeland Roman Catholic Separate School Division)  
This tax is levied by the provincial government to fund education across Alberta and is collected by the City of Cold Lake on behalf of the province and school divisions.

● **Seniors Tax**  
(Lakeland Lodge and Housing Foundation)  
This funds improvements to seniors lodge accommodations in the Cold Lake-Bonnyville area and is collected by the City of Cold Lake on behalf of the local seniors foundation.

● **Municipal Tax**  
(City of Cold Lake)  
This includes infrastructure, recreation and culture, administration, planning and economic development, emergency services, and public health and welfare at the city level.

# COLD LAKE AIR WEAPONS RANGE

The City of Cold Lake achieved its goal of permanent, stable funding through the former I.D. 349 when Order In Council 121/2020 came into effect. The order annexed the former I.D. 349 to the M.D. of Bonnyville and mandates a formula for distribution of property taxes from the former Improvement District. The distribution formula was made through a consensus between the City of Cold Lake, M.D. of Bonnyville, Town of Bonnyville, and the Village of Glendon.


The formula provides the M.D. with money for road maintenance and administrative costs, a base amount for all urban municipalities, and then divides the remainder between the urban municipalities on a per-capita basis. The per capita numbers are updated by the province periodically.

# PLANNING AND DEVELOPMENT

It was another busy year with an increase in building and development activity, as well as several new projects that were launched.

Work continued on the City's new Land Use Bylaw, which was formally adopted by Council in February of 2023.

The City also adopted a new bylaw to regulate the operation of taxi services in the City, aimed at enhancing the safety of taxi vehicles and ensuring that rates are displayed clearly for customers.

The City issued a Notice of Intent to Annex two quarter sections of land from the M.D. of Bonnyville that are located adjacent to English Bay Road.

The proposed annexation is being driven by a planned estate-style residential development. Discussions with landowners commenced in the fall of 2022, with a formal annexation application to be submitted to the Provincial Land and

Property Rights Tribunal for formal approval in 2023.

Significant permits issued during 2022 included the new Stepping Stones Crisis Centre, a new commercial development at the Tri-City Mall, and the new Public Works Operations Centre. The City also approved a new facility for the John Howard Society.

Another significant milestone was the approval of the first new residential subdivision in over eight years. A 37-lot expansion of the Parkview neighbourhood, located just west of the hospital, was approved, with construction expected to start in 2023.

The City also launched a project in conjunction with the M.D. of Bonnyville to develop an Intermunicipal Trails Plan. The plan will identify potential trail links between the City and areas in the M.D. The consulting team spent several weeks in the area during the spring and summer of 2022 talking with trail users, as well as conducting an online survey to gather feedback. The final plan is expected in 2023.




# COLD LAKE THROWBACK

The Cold Lake Marina has always been a focal point of the community for both locals and visitors, and has seen significant expansion since 1931. The marina now boasts over 230 slips, a renovated boat launch, kayak storage, and fuel for sale.

# COLD LAKE TRANSIT

As 2022 arrived, Cold Lake Transit saw the impact of COVID-19 related health restrictions slowly fade. As a result, ridership on Cold Lake Transit gradually increased. Student ridership saw a large jump in 2022 as students returned to school full time. In total, Cold Lake Transit accommodated a 34-per-cent increase in ridership over the previous year.

In March of 2022, the City of Cold Lake entered into an agreement for the Alberta Relief for Shortfalls for Transit Operators (RESTOR), which included a commitment to take steps towards increasing housing supply, density, and affordability. The City received just over \$123,600 in RESTOR funding, utilizing it to cover the reduced revenue received from special transportation, and to maintain the Cold Lake Transit's safe operation through the COVID-19 pandemic.



## Monthly Ridership 2020-2022




The City also purchased a used low-floor transit bus to offset the much older MCI bus that was in rotation as a backup. Having the new low-floor bus will ensure that Cold Lake Transit consistently offers service accessible to people with mobility concerns across both routes. This bus was retrofitted externally to match the branding of the rest of the City Transit Fleet.

While 2018 was Cold Lake Transit’s busiest year with over 172,800 rides, the health restrictions in 2020 saw a drastic decrease in ridership of almost 53 per cent. Since then, ridership has increased by 65 per cent to just over 135,400 rides in 2022, representing a strong return to the use of public transit in the City of Cold Lake.

# INFRASTRUCTURE

The City of Cold Lake's Infrastructure Services Department encompasses many different functional areas. These include Engineering, Geographic Information Systems, Water and Wastewater Treatment, Water Distribution and Collection, Waste and Recycling, Fleet Maintenance, Roads, the Cold Lake Regional Aerodrome, and Cold Lake Transit.

The City's annual Capital Street Improvement Program is the core road maintenance program delivered by the City. It is governed by a road analytics program that uses the surface distress index of the roadways to assist the Engineering Department in determining the most cost-effective plan to upgrade, repair, and reconstruct the road system each year.

The 2022 Capital Street Improvement Program received about \$2 million in funding. On average, roughly \$2 million in work is required each year to maintain the condition of the City's road infrastructure

at its current condition and this level of spending is consistent with achieving maintenance goals. About \$1.48 million was spent on road projects outside of the Street Improvement Program for a total of \$3.52 million in road infrastructure spending in 2022.

Other capital projects have significant impacts on road conditions. The Lakeshore Drive Infrastructure Improvements project, for instance, will improve all underground pipes, improve drainage in the area, improve slope stability on the lake side of the road, add a linear parkway and rebuild the road entirely.

Construction on this project is expected to begin later in 2023.




The City of Cold Lake operates the Cold Lake Water Treatment Plant under contract with the Cold Lake Regional Utility Services Commission. In 2021, the treatment plant began producing water for distribution and sale to the Bonnyville Water Commission.

Over one million cubic metres of water were distributed to the Bonnyville commission, or just over 2,823 cubic metres each day, down from about 3,500 cubic metres a day sent via the 41-kilometre transmission line in 2021.

Water distribution also fell slightly in Cold Lake North and South in 2022, as well as at the water fill station, although 4 Wing Cold Lake bucked the trend and saw an increase in distribution.

# INFRASTRUCTURE

The 2022 Capital Budget was passed with just under \$24.6 million in projects, many of which are delivered through the Infrastructure Services Department.

The Public Works Operations Centre also received an additional \$11 million in funding so that it can progress to completion of the current phase. Work preparing the site of the new building has begun with construction also expected to begin in 2023.

In 2022, the City facilitated concrete recycling, which represented 29 per cent of all material recycled by weight. Concrete recycling occurs on a periodic basis as enough material is collected.

Cardboard remains the main recycling commodity, with 1,582 tonnes being collected and baled at the Material Recovery Facility, down from 1,889 tonnes in 2021.

## Top 3 Recycling Streams by weight (tonnes)







With over 60 members today, Cold Lake Fire-Rescue continues to put in the time and training to ensure they are ready to serve their community. In 1998, the Cold Lake and Grand Centre Department merged to form Cold Lake Fire-Rescue.

# COLD LAKE FIRE-RESCUE


With the lifting of restrictions due to the Pandemic, returning to normal operations was a priority. Cold Lake Fire-Rescue members were able to participate in regional certified training courses. Gathering in the fire stations for skills maintenance training was also reintroduced to improve morale and redevelop team dynamics.

In spite of the changing restrictions, Cold Lake Fire-Rescue managed to complete a regional National Fire Protection Association (NFPA) 1001 Professional Firefighter program, and run a recruit class for eight firefighters in 2022.

Cold Lake Fire-Rescue is responsible for ensuring that our people and equipment are ready to safely and effectively respond to emergency incidents.

This response capability is maintained by a cadre of 60 plus "Paid on Call" firefighters and three headquarters staff, who are on-duty around the clock.



## Incident by type 2020-2022




Cold Lake Fire-Rescue firefighters spent 7,772 hours on operational taskings in 2022, along with 2,901 hours for skills maintenance and 1,992 certified training hours. This has allowed Fire-Rescue to maintain a high level of qualifications, with 79% of the firefighters qualified to NFPA 1001 Level 2 standard for professional firefighters.

Cold Lake Fire-Rescue serves the City of Cold Lake, a large portion of the M.D. of Bonnyville, Cold Lake First Nations, Elizabeth Métis Settlement, and a portion of the Rural Municipality of Beaver River, Saskatchewan, for a total area of approximately 2,500 square kilometres.

Emergency services provided are: urban and rural fire suppression; rescue operations including vehicle extrication and technical rescues (confined space, trench, surface ice, and rope rescue); and special operations including urban-wildland interface firefighting and dangerous goods response.

# MUNICIPAL ENFORCEMENT

In 2022, Cold Lake Municipal Enforcement operated with six Community Peace Officers working in an eight-hour rotating schedule, three part-time Bylaw Officers, and two casual bylaw officers. In the 2023 operating budget, council funded a shift to 24-hour coverage.

Municipal Enforcement works to inform the public about municipal bylaws, educate the public about compliance, and works to enforce the bylaws.

Officers also enforce speeding regulations through the use of radar, joint initiatives

with the RCMP detachment, as well as through passive speed signs which are moved throughout the community to inform motorists of the speed they are traveling.

Municipal Enforcement also patrols City parks and facilities, ensuring public safety issues are noticed and performing lock-up duties as needed.

Municipal Enforcement also performs animal control duties throughout the community, including on 4 Wing Cold Lake.

## Municipal Enforcement Total Calls 2014-2022




# COLD LAKE VICTIM SERVICES




# COLD LAKE RCMP

The Royal Canadian Mounted Police at Cold Lake had a detachment strength of 44 personnel in 2022. The detachment was comprised of 1 Staff Sergeant, 2 Sergeants, 5 Corporals, 25 Constables, and 11 Detachment Clerks (7 Municipal employees and 4 Public Service employees).

The detachment area is geographically large and diverse, covering the City of Cold Lake, the eastern portion of the M.D. of Bonnyville, the Cold Lake First Nations, and the Elizabeth Métis Settlement.

Cold Lake generated a total of 11,410 files in 2022; an increase of 662 files, or 6.2 per cent, when compared to 10,748 files generated in 2021. Of the total, 7,558 files were generated in the City of Cold Lake, a 12.4 per cent, or 834 file increase, when compared to 6,724 files generated in 2021. The Cold Lake RCMP detachment generated 3,852 files outside the City of Cold Lake, a 172 file decrease or -4.27 per cent, when compared to 4,024 files generated in 2021.




# COLD LAKE AND DISTRICT FCSS

In 2022, Cold Lake and District FCSS and the Cold Lake Family Connections Centre employed 10 program-related staff positions. Its operations and programming are overseen by a committee consisting of five volunteers and two Council members.

FCSS's goal is to provide locally driven, preventative social initiatives that are based on current issues in the community and which aim to improve the quality of life for individuals and families. FCSS also lends equipment that can be used to host community events, including games and toys. In 2022, the resource lending library was accessed for 421 items, supporting events attended by over 2,780 people.

When a community member requires access to programs or services, FCSS staff endeavor to bridge the gap between community members and a variety of service providers, widening the safety net available. Services include low-cost housing, addictions, financial supports, mental health services and more.



# COLD LAKE ENERGY CENTRE

The Energy Centre started 2022 off with health restrictions in place. Those were dropped in February, so staff cautiously moved forward with planning programming. With the pandemic behind us, the facility more than doubled new members to 3,147 from 1,429 in 2021.

Facility drop-ins also returned in similar fashion with 5,808 drop-ins in 2022, compared to 2,753 the year prior.

Large events were slow to return, but by April public events were back in full swing with over 1,500 people attending the Energy Centre's Easter Party. Summer events such as Canada Day and Aqua Days also returned, and attracted over 8,000 people between the two events, despite challenges with weather.

Cold Lake North Arena underwent an interior renovation which included updated dressing rooms, lobby, and viewing area. The renovation also included new washroom facilities as well as a new upper level viewing section. All areas have new flooring, doors, paint, lighting, and a new etched glass trophy case has been installed in the facility.



# COLD LAKE GOLF & WINTER CLUB

This was the 10th season since the City of Cold Lake took over operations of the Golf and Winter Club and the sixth season of complete turf maintenance responsibilities.

Since taking over turf maintenance responsibilities, the course conditions continue to improve as more projects on the course are completed.

The facility welcomed 326 bookings throughout 2022. This included all curling and golf league play, tournaments, and all bookings that took place within the facility.

Men's and Ladies' golf leagues returned for 2022, running from May until September. All of our club tournaments returned back to normal play, bringing back the social atmosphere in the club.

Membership went down from 211 to 198 in 2022. Improvements to four more of the bunkers most needing attention were completed. Planning is underway for more improvements for the Cold Lake Golf & Winter Club's bunkers in 2023.





# MARINA AND PARKS

Phase 2 of the marina boardwalk rehabilitation project commenced, which replaced aging wood planks with new composite decking. Phase 2 was completed up to the marina office. The final phase was completed in the summer of 2023, which included replacement of the remaining decking on the east side of the boat launch.

Capital money was allocated in the 2022 budget to purchase and upgrade some highway seasonal lighting in the City. The remainder of the older lights are scheduled to be replaced in 2023.

In 2022, noxious weed inspections increased, which had a positive impact

on maintaining the overall look of the community. Vegetation management is an ongoing project which the City plans to expand and work with residents to help with problem areas identified in the community.

The Garden Bed Maintenance contract has continued to be very successful. Expansion of the contract is being considered for the upcoming 2023 season.

A garden rejuvenation project was completed at City Hall. New site furnishings were also added to allow residents an accessible area to sit and enjoy the landscape.

# COLD LAKE PUBLIC LIBRARY

The Cold Lake Public Library operates separately from the City of Cold Lake. The information presented here is provided by the Cold Lake Public Library and presented for the public's information.

Cold Lake City Council continued to fund library memberships in 2022, continuing an initiative that started in 2016.

The library continued its path of growth in 2022, adding 356 memberships from the previous year, for a total of 1,910 members over the course of the year, serving 32,827 people who walked in through the doors. A total of 98,879 items were checked out of the library.

The library has a compliment of 13 staff members and two dedicated volunteers to serve the public over the course of the 5,188 hours the facilities were open.

The use of public computers continues to be in high demand, with nine public computers available and a total of 48,919 connections made to the library's Wi-Fi.




